Introduction

OBJECTIVES

As **Better Regulation** – the strategy to simplify and improve the regulatory environment for citizens and businesses - continues to be a key priority for politicians and public administrations at all levels of government in and beyond the European Union, it is becoming increasingly important for public officials, businesses, NGOs and social movements, to understand what Better Regulation is about and what it is likely to mean for them.

By the end of this interactive online seminar, participants will understand:

- why Better Regulation has been highlighted as a key policy priority in the European Union institutions and Member States;
- the key principles underlying the development of Better Regulation strategies across the European Union;
- the potential opportunities and challenges to public administrations and stakeholders from introducing and applying Better Regulation practices across Government;
- how the main Better Regulation practices are being applied in the EU institutions and in Member States, and the lessons learned from their application.

Given that Better Regulation affects all policy areas, the seminar will be important for officials from most Ministries and agencies, particularly those who are required to work with Better Regulation tools and approaches, such as Impact Assessment, Simplification, and measurement of Administrative Burden. It will also be of interest to stakeholder groups and policy researchers.

METHODOLOGY

The programme will be offered as an online seminar. The participants receive a *password-based* access to EIPA web pages where they can *view* or *download*:

- video recordings of presentations by various experts on different aspects of Better Regulation. The recordings will be drawn from existing courses offered in Maastricht and additional recordings will be made specifically for INAP purposes
- recorded interviews with stakeholders and Better Regulation experts
- PowerPoint presentations of the recorded lectures
- supporting documents and materials, which will allow the participants to deepen their understanding of Better Regulation techniques.

The participants will receive requests for two written assignments a few weeks after registering for the course. The assignments will focus on Better Regulation efforts and challenges in Spain. The participants will be required:

- to do group and independent research on Better Regulation in Spain
- to post their assignment results online on the EIPA web pages
- to review and comment on the contributions of the other participants
